- Applying machine learning, statistical modeling, and data integration approaches to guide large-scale functional screens with the goal of identifying and optimizing functional elements for gene therapy payloads.
- Developing scalable, reproducible, and well-documented pipelines for quality control, processing, and integrative analysis of diverse high-throughput sequencing datasets.
- Integrating publicly available and internal datasets to uncover actionable biological insights that inform payload design.
- Staying current with emerging technologies and advances in bioinformatics, gene therapy, and synthetic biology, and proactively propose innovative approaches to improve experimental design and analysis.
- Presenting results, methodologies, and key insights to multidisciplinary teams and stakeholders through clear visualizations, written reports, and scientific presentations.
