  and enable a range of high-profile strategic projects to address the unmet needs of HCP and patients and
  strengthen Novartis' reputation.
- Engage early and timely communicate with internal stakeholders including senior management, marketing, sales, VA, PA, Comms & PA and medical on compliance related matters to provide valuebased insights.
- Keep up to date on the regulatory environment and any internal change and promptly identify the emerging risks and come up with solutions to better support business enablement.
