- Identify DI training needs, develop relevant materials, and facilitate training delivery.
- Provide site support for DI-related investigations, escalations, reviews, and audits (internal and external);
   serve as SME for DI and contractor/supplier management during audits/inspections
- Lead and monitor execution of the site DI Plan, including communication and engagement activities; report progress to site leadership.
- Manage contractor qualification and oversight (quality agreements, audits, risk assessments, surveillance planning).
- Align with contractor managers across the campus to ensure consistency and best practices; support implementation of global processes related to DI and contractor/supplier management
